2023 ANNUAL REPORT

JAMF received 88 submissions for a total request of \$6,304,000. Of these, JAMF awarded \$1,223,000 to 49 projects, with grants ranging from \$2,000 to \$51,000. A breakdown of grants per priority area shows that projects benefiting Children & Youth of Coos, Curry, & Coastal Douglas Counties received the most grants, followed closely by Economic Development projects.
